1. If MULTIPLE violations/citations, the total amount MUST be given through the phone # above.
2. A \$20.00 Late Fee is assessed when a fine is paid after the court date and time on the ticket.
3. Any check tendered to the Broadview Heights Mayor's Court that is returned shall incur a \$25.00 Returned Check Fee and a \$20 Late Fee if paid after the court date and time on the ticket.
4. Please call the phone number above to verify the TOTAL amount due and to verify if your ticket is Waiverable.
5. When a bond is taken, it is a mandatory Court Appearance.
6. When paying on a Payment Plan Agreement, a copy of the agreement must be included. Monies are not accepted beyond the due date. When beyond the due date, the defendant must contact the Clerk of Court direct at 440-526-4895 x 4.
