**A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT
BETWEEN THE CITY OF BROADVIEW HEIGHTS AND CERTAPRO PAINTERS
FOR PAINTING THE NATATORIUM WALLS IN THE CITY OF BROADVIEW
HEIGHTS AND DECLARING AN EMERGENCY**

WHEREAS, the City Council has determined that it is in the best interest of the City to enter into an agreement between the City of Broadview Heights and CertaPro Painters for painting the natatorium walls in the City of Broadview Heights.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BROADVIEW HEIGHTS, COUNTY OF CUYAHOGA AND STATE OF OHIO:

SECTION 1. The Mayor is hereby and herein authorized to enter into an agreement between the City of Broadview Heights and CertaPro Painters for painting the natatorium walls in the City of Broadview Heights as delineated in Exhibit "A" attached hereto and made a part hereof as if fully rewritten.

SECTION 2. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, peace, safety and welfare for the reason stated in the Preamble hereof, and provided it receives the affirmative vote of five (5) or more of the members of Council and signature of the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.

Re: **AGREEMENT WITH CERTAPRO PAINTERS**

The Parks & Recreation Department is requesting Council's authorization to enter into an agreement with CertaPro Painters that is located in Brecksville. The natatorium walls need to be painted at shut-down this year. There are areas of discoloration, peeling, and staining that cannot be cleaned any further. We reached out to 4 companies and only two accepted the opportunity to give us a quote. Both Painting Solutions declined the project. Martin Painting and Coating traveled from Grove City to provide a quote for us. They came in just under \$30,000. CertaPro Painters is just under \$24,000 and will be providing a 2-year warranty on the project. They are also licensed and bonded in Broadview Heights. Martin Painting was only a one-year warranty. We planned for this project in our 2025 budget. The quote is attached.

Pressure wash walls to remove any dirt
Protect flooring
Replace panel sealant that is cracking with SW Loxon H1
Apply SW Pro Industrial Catalyzed Epoxy Paint to the walls

Paint, materials, labor, lift rental, tilt up sealant

EXCLUDES:

SURFACE PREPARATION

Standard Prep - The goal is to make sure the surfaces are solid, sealed and fully protected and the appearance improved, with a specific focus on high visibility areas. Cracks, gaps, open nail pops and holes will be repaired, trim will be scuff sanded, large divots and nicks patched and sanded, cracks and gaps caulked, and spot primed prior to painting. Paint lines will be cut as straight as possible given underlying surfaces. However, an older home often shows the wear and tear of age – and based on the current condition, there may be blemishes left with the underlying surfaces.

CLEAN UP

Daily: Ladders are taken down and stored in a designated area along with all other tools and supplies. All debris will be swept and removed from the property or deposited in the appropriate trash receptacle according to the customer's preference. Upon Completion: All tools, supplies & equipment will be removed from the property.
