
WHEREAS, the Broadview Heights Fire Department wishes to donate 4 sets of obsolete turnout gear to the Middle Bass Fire Department.


SECTION 1. The Mayor is hereby authorized to donate 4 sets of turnout gear to the Middle Bass Island Fire Department.

This Resolution is declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason stated in the Preamble hereof, and provided it receives the affirmative vote of five (5) or more of the members of Council and the signature of the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.

Passed and Adopted by the Council on this 2nd day of September, 2025






