WHEREAS, the City Council has determined that it is in the best interest of the City to enter into a memorandum of understanding between the City of Broadview Heights and the Cuyahoga County Sheriff’s Department regarding radio communications in the City of Broadview Heights.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BROADVIEW HEIGHTS, COUNTY OF CUYAHOGA AND STATE OF OHIO:


SECTION 1. The Mayor is hereby and herein authorized to enter into a memorandum of understanding between the City of Broadview Heights and the Cuyahoga County Sheriff’s Department regarding radio communications in the City of Broadview Heights as delineated in Exhibit “A” attached hereto and made a part hereof as if fully rewritten.

SECTION 2. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, peace, safety and welfare for the reason stated in the Preamble hereof, and provided it receives the affirmative vote of five (5) or more of the members of Council and signature of the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.

This Memorandum of Understanding ("MOU") is made between the County of **Cuyahoga ("County")**, a County of the State of Ohio, through its Sheriff's Department, and **Broadview Hts. Police Department ("Agency")**, through its authorized representative.

WHEREAS, the Cuyahoga County Sheriff's Department provides incident and exercise support to **Broadview Hts. Police Department**.

WHEREAS, interoperable radio communication is necessary during incident response and exercises

WHEREAS, normal incident radio communication occurs on local talk groups and not County-wide interoperable talk groups

WHEREAS, Cuyahoga County Sheriff's Department has radios to enable on-scene radio communication with other responders

NOW, THEREFORE, the Cuyahoga County Sheriff's Department is authorized to have the talk groups used by **Broadview Hts. Police Department** programmed into their radios and dispatch consoles.
