2. All contractors must be registered with the Building Department to work in the City of Broadview Hts.
3. Prior to excavation; the Applicant must call O.U.P.S before you dig. By law Contractors and Homeowners should contact OHIO811, 8-1-1 or 1-800-362-2764, at least 48 hours but no more than 10 working days (excluding weekends and legal holidays) or submit their request online with the remote ticket entry system; Homeowner's please use this link e-dig and for Contractors please use this link i-dig Newtin RTE. Water lines are not located through O.U.P.S you can reach the City of Cleveland Water Dept. at (216) 664-3060 to mark the water lines at the site.
4. The cost of said Street Opening Work within the Town's Right of Way including; labor, materials and any expense incurred necessary to perform the Street Opening Work in accordance with the regulations is the responsibility of the contractor/owner.
5. A performance bond in the sum of \$1,000 for bore and or 5,000 for open cut is required for the Street Opening Permit which is determined at once the permit is submitted for review.
6. If the work that is being performed obstructs traffic flow then the applicant is responsible to contact the Broadview Hts. Police Department for arrangement of details and payment of the details throughout the period of time that the Street Opening Work
