Submittal

Sufficient copies of the drawings must be submitted with the application. Three (3) sets of Residential **and supporting documentation**

In addition to the hard copies please submit electronic copies of all documentation (USB flash/jump drive, file transfer, cd)

Fees

New wireless telecommunications tower and facility: \$2,000

New wireless telecommunications antenna: \$500

Co-location of a wireless telecommunications antenna on an existing tower or building: \$500

Payment Methods:

Fees can be paid by cash, check or credit card (3.5% service charge a \$0.50 minimum charge).
