Registration are valid from January 1st of the current year and expires on December 31st of the same year.

We do not accept registration by email. All registrations need to be submitted in person or by regular mail.

Any and all general contractors, specialty contractors, subcontractors and landscapers performing any work within the City, (regardless of whether a permit is required) shall be required to register with the City and the Regional Income Tax Agency (RITA) prior to beginning any work within the City. Contractors who begin work in the City without first registering may be subject to additional fees, a stop work order and/or a court citation.

We do not allow the registration to run from December of the current year to December of the following year; no grace period is given in the month of December for the following years registration.

If you are the General Contractor on the project the registration process applies for all the subcontractors who will be working on the job. We do not issue permits until all contractors are registered for the year the work will be performed and have up to date insurance, workers comp and state license.

ANY APPLICATION MISSING ANY INFORMATION WILL NOT BE PROCESSED AND WILL BE RETURNED.

NOTIFICATION: If you do not submit your application in person, you must provide a self addressed stamped envelope if you want a hard copy sent back to you through regular mail or a valid email address for us to send it electronically.

PAYMENT: The fee for an annual registration is one hundred dollars (**\$100.00**). No refunds.

We accept Cash, Check, or Credit Cards (3.5% services fee). Cash, Checks and Credit Cards are accepted in person but you can pay by Credit Card online by clicking the "Pay Here" link on the bottom of the building department page. You will need a application number; which the building department will provide to you once your application has been approved. Make checks payable to City of Broadview Heights.

CONTRACTOR CATEGORIES:

Those engaging in work as a registered contractor, either by hire, contract or subcontract, shall be registered for each classification type. The wording of your classification must match the wording on the bond. You may state an additional classification type on the application **ONLY** if both classification types are listed on the bond.

The following contractor categories **MUST** submit a Current State License with their application:

**Electric, Plumbing
HVAC
Refrigeration**

**Hydronic
Fire Supression
Fire Protection**



Contractor Registration

BOND:

- A twenty-five thousand dollar **(\$25,000.00)** bond
- The bond shall be on a **Broadview Heights Bond Form**
 - Must have insurance company's seal/stamp
 - Power of Attorney attached.
- The **bond effective date** has to be the current year of the registration and the **expiration date** shall be December 31st of the current year and this is annually.
- No Continuation Certificates will be accepted.
- No grace period is given in the month of December for the following years registration..
- All registrations start January 1st of the registration year and end on December 31st of the same year.
- Either the principal or an authorized representative of the company **MUST sign the bond form.**
- We will only accept the **“original”** stamped/sealed bond form
- The bond form may be downloaded by your insurance company from the City's website: www.broadview-heights.org

CERTIFICATE OF INSURANCE:

- The Certificate of Insurance must list bodily injury **\$100,000/\$300,000** and property damage of least **\$50,000**.
- The City of Broadview Heights must be listed as a Certificate Holder.
- The Certificate of Insurance will expire on December 31st of the current year.
- If the insurance certificate expires during the year it is your responsibility to submit a new certificate.

WORKER'S COMPENSATION:

- A Copy of your Current Worker's Compensation Certificate must be included.
- If you are a **SOLE** Proprietor with **NO EMPLOYEES** other than yourself, you must note the fact on the application.
- If the worker's compensation certificate expires during the year it is your responsibility to submit a new certificate.

RITA BUSINESS REGISTRATION FORM 48:

- If **you are not** currently paying taxes to RITA in Cuyahoga County, you must fill out and submit **FORM 48** online at **<https://ritaohio.com/>**.
- If you have a Federal ID Number you must list it on the Contractor Registration Application.
- **It is the responsibility of ALL contractors to notify RITA at <https://ritaohio.com/> with the number of days & locations of work that the company does in Broadview Heights.**

IMPORTANT NOTES:

- All Contractor/Building Trade Registrations shall expire on December 31st of the year of issuance.
- All Workman's Compensation Certifications expire on June 30th of every year.
- The expiration of any of the required documents may delay permit approvals and inspections for the project.
It will be the responsibility of the company or representative to submit new documents when they expire.
- All Certificates must be re-submitted each year with your registration, regardless of expiration dates.
- **Bonds that are cancelled by your insurance company for any reason will also cancel your registration.**
